Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily US Tech 100, Wall St 30, US SmallCap 2000, and US 500 Binary Contracts for Trade Date December 21, 2012. Nadex returned to its regular listing schedule for these contracts on December 24, 2012.

New strikes created on trade dates December 21, 2012 are set forth in Exhibit A.
